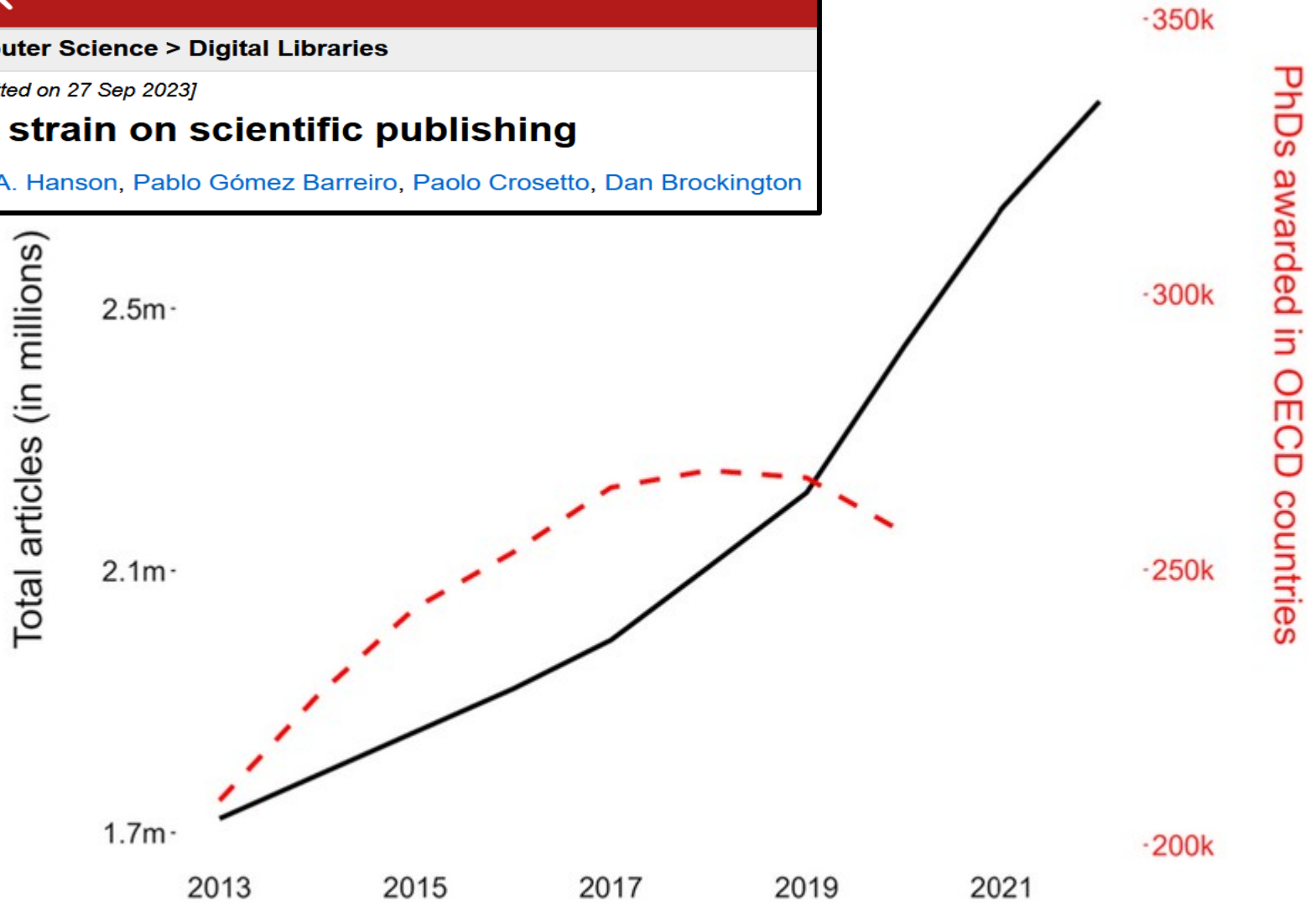

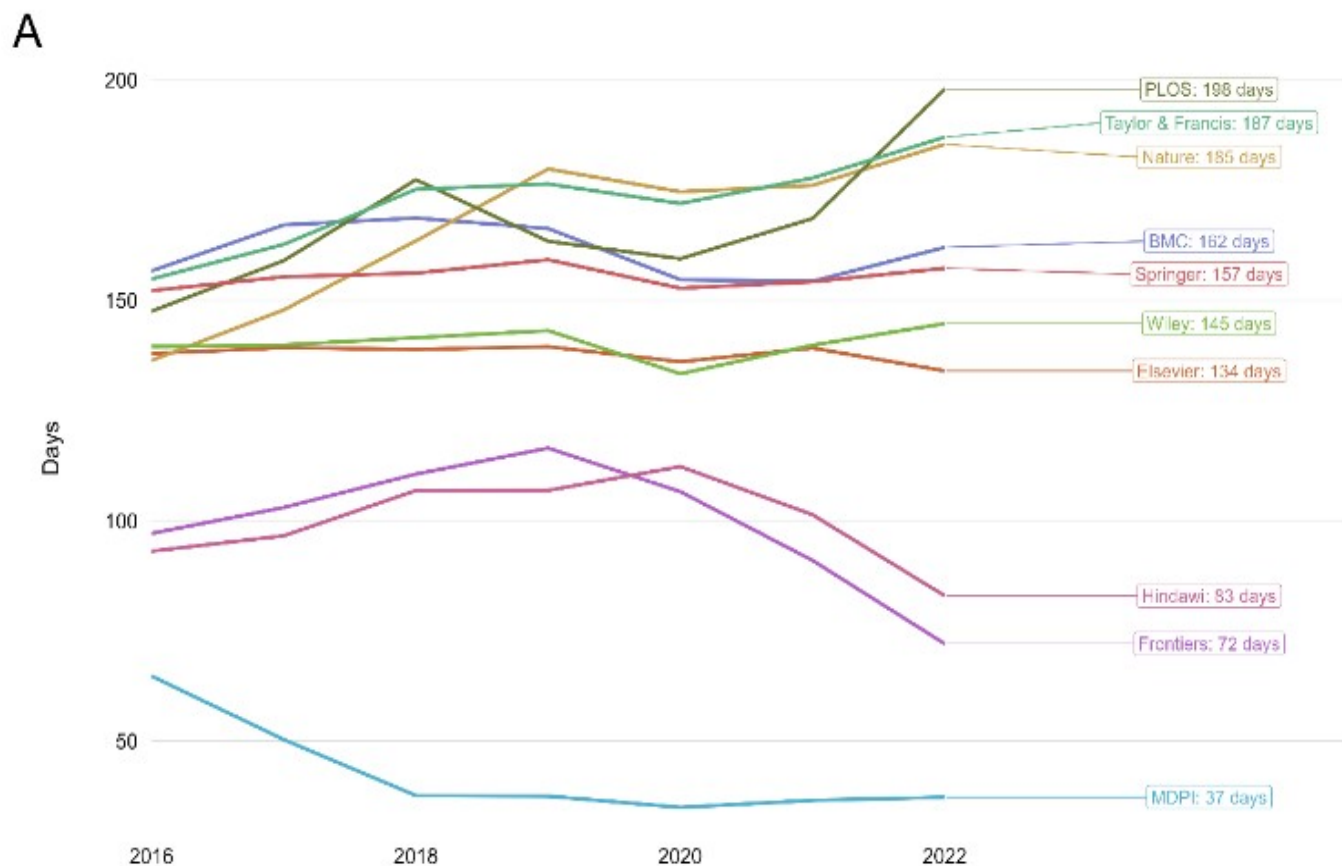

Fig.1: Growth in indexed articles (solid line) and new PhDs (dotted)

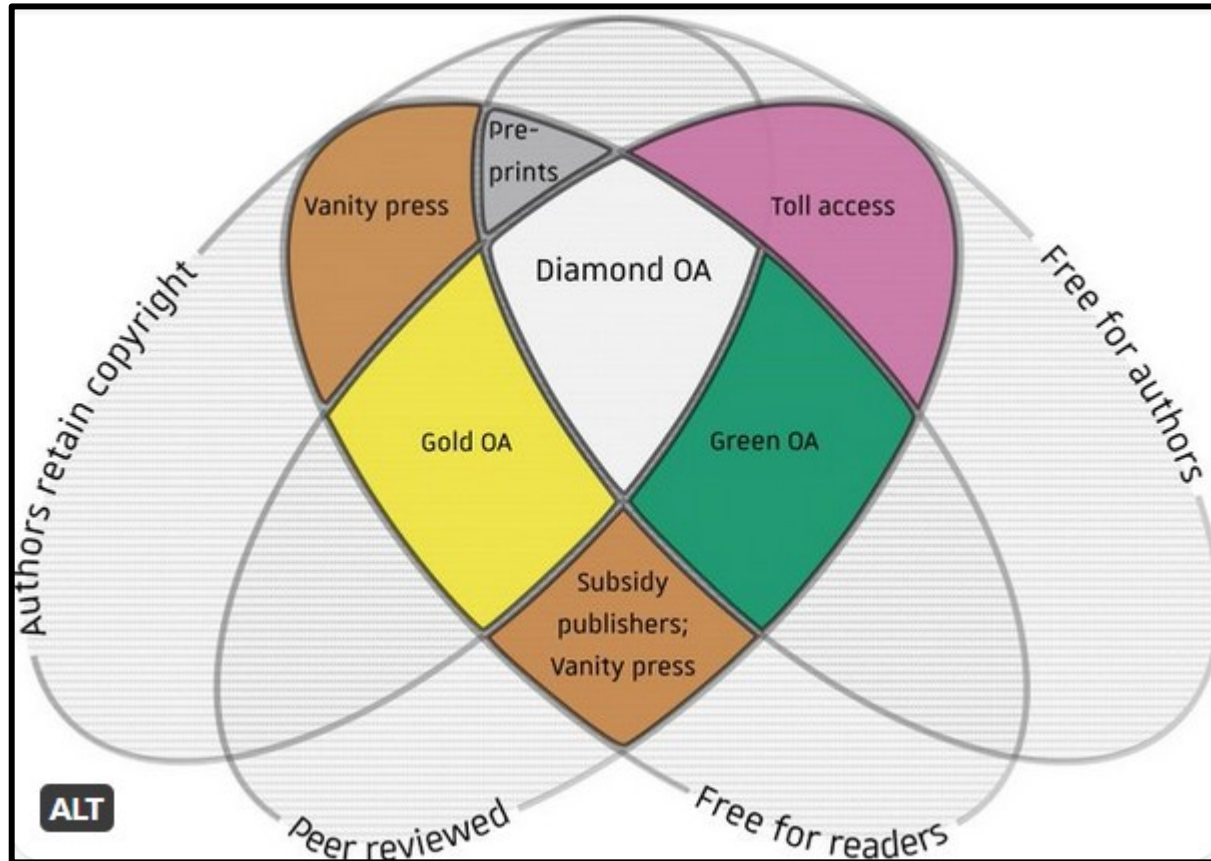

« *Predatory journals and publishers are entities that prioritize **self-interest** at the expense of scholarship and are **characterized by false or misleading information**, deviation from best editorial and publication practices, **a lack of transparency**, and/or the use of **aggressive and indiscriminate solicitation practices** »

- Fake journals ; hijacked journals (Salim, 2021)
- Rebrandings (Siler, 2021)
- Fake standards: ISSN, DOI, IF, ...
- Cannibalism (McCrostie, 2018)
- Paper mills (Labbé & Cabanac, 2021)
- Copy/Past, patchy Papers
